

# ONLINE PRIVACY POLICY

This Online Privacy Policy (“Policy”) is a part of and is incorporated into the Terms of Service Agreement (“Agreement”) for the avhuntertrust.org website. Avhuntertrust.org is a website (“Site”) of the A.V. Hunter Trust, Inc., a non-profit foundation organized under the laws of Colorado. Certain capitalized terms used here are defined in the Agreement.

We respect the privacy rights of our online visitors and recognize the importance of protecting the information collected from you. This Policy applies to information collected about you upon access to the Site. This Policy guides how we collect, store and use the information you provide online. This Policy applies only to websites maintained by A.V. Hunter Trust, Inc. and not to websites maintained by other unaffiliated organizations to which we link.

If you have questions or concerns regarding this policy, you should first contact A.V. Hunter Trust, Inc. at the email address or postal address posted on the homepage.

## **What Information We Collect From You**

This policy applies to information that personally identifies you (“Personal Information”). It does not apply to information that is considered publicly available. We may collect both personal and public information. Our primary goals in collecting Personal Information are to provide you with the information, resources and services made available through the Site, and to communicate with you.

Both Personal Information and public information about you may be collected directly from registrations you complete and submit to us on the Site. This information may also be collected indirectly from your access to the Site.

Some information about you is collected automatically when you access the Site. The Site will automatically record information that your browser sends whenever you visit. Collected data may include information such as your IP address, browser type or the domain from which you are visiting, and the search terms you use. We use this information to monitor your use of the Site and its services, and for the Site’s technical administration. We do not associate your IP address with any other Personal Information in order to identify you, except in case of violation of the Agreement.

We use cookies and other technologies to track and monitor your movements within the Site. We may link this usage information to your Personal Information such as your domain name and host for internet access; the internet address of the site from which you came; the date and time of your access; your computer’s IP address and information about its operating system, browser and host; the date and time you access the Site and the pages you have viewed. Most browsers are automatically set to accept cookies whenever you visit a website. You can disable cookies or set your browser to alert you when cookies are being sent. The web based system will issue cookies when you access the Site, unless you have disabled them on your browser. If you disable cookies, you may not have access to some of the Site’s services or certain features of the Site may not function properly.

## **What We Do With Collected Information**

We use both Personal Information and public information collected about you to carry out business activities in connection with our charitable programs. Information obtained during your Site visit may be used to examine the patterns of Site usage in order to improve the Site design and functionality.

## **Other Parties**

Other parties with websites accessible through this Site may require you to disclose Personal Information in order to register for or gain access to their information or services. Your Personal Information will be subject to the privacy policy and practices of the other party. A.V. Hunter Trust, Inc. is not responsible for the privacy practices and policies of the other party whose

information or services are available through this Site. You should review the privacy practices and policies of the other party prior to providing your Personal Information in connection with such information or services.

**What Information Do We Share With Others**

We do not, except as noted below, share or disclose your Personal Information with other parties for any purpose which is not related to A.V. Hunter Trust, Inc. charitable activities.

Personal Information may be shared with other parties who provide services to us, at our direction and only in connection with our business activities. Our service providers are obligated to keep Personal Information we share with them confidential and use it only to provide services specified by us.

We cooperate with government and law enforcement officials or private parties to enforce and comply with the law. We may disclose any information about you to government or law enforcement officials or private parties as we, in our sole discretion, believe necessary or appropriate to respond to claims, comply with legal process (including subpoenas), protect the property and rights of A.V. Hunter Trust, Inc., or a third party, enhance the safety of the public or any person, to prevent or stop any illegal, unethical, or legally actionable activity.
